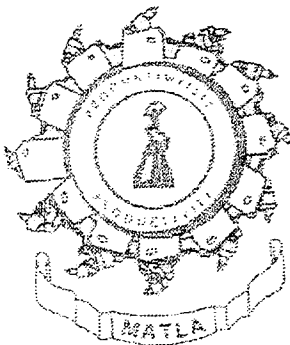
We are replacing the tyres today due as they are now worn out but have not had a single puncture from the date Survival SP3000 was fitted.


